This is the report of the Town Council and reflects the activities and services it has delivered from May 2019 to April 2020.

The Council consists of 16 councillors, all elected every four years. Two of the councillors are also Stratford on Avon District Councillors and one a Warwickshire County Councillor. The Mayor is a Councillor elected annually by the members of the Council and acts as Chair of the Town Council.

The parish is divided into three wards, Alcester West, Alcester-Oversley and Oversley Green (see back page for representation).

The Town Council is responsible for the following:



Meetings and purpose:

Presidium meets on the last Tuesday of each month, a week before Full Council to receive reports, discuss issues arising from them and to confirm the Agenda for Full Council.

Presidium acts as a Finance Committee with the Town Clerk reporting and discussing financial details. A report is subsequently made to Full Council. The Town Council received an unqualified report from its external Auditors

with no matters reported which required attention for the year ended April 2019.

The Mayor, the Deputy Mayor and Immediate Past Mayor acted as a Staffing Committee reporting to Presidium and subsequently to Full Council.

Meetings: The Planning Committee met on 15 occasions throughout the year, and considered over 80 Planning applications, all of which are minuted (see the Town Council website). Objections were made on 19 occasions. Site visits were conducted on 2 occasions, and public representation occurred at 6 meetings. Committee members attended 3 Stratford on Avon Area Planning Committee B meetings.

Please note that in the parish of Alcester, Stratford on Avon District Council (SDC) is the planning authority and as such process all planning applications and make decisions on each application. Alcester Town Council is a **statutory consultee** in the planning consultation process. It does not make decisions.

Applications of significance:

SIG Roofspace, Alcester Heath (19/02996/VARY): Variation of Conditions 2, 8, 10 and 15 to amend the plans to include a proposed 21-space staff car park within planning permission reference 17/03089/FUL. Objection was made based on concerns for both the safety of large vehicle movements and cars accessing the site at the times proposed. REFUSAL OF VARIATION

Garages, North of Castle Road (19/02449/FUL)- Demolition of all existing garages and construction of five dwellings, creation of associated parking area and all other associated works : An objection was made as it was considered to

be over development and the car parking was not well designed. The proposal was amended and the objection withdrawn. PERMISSION WITH CONDITIONS

Alcester Neighbourhood Plan: A Steering Committee was appointed in 2017, chaired by Wendy Mills, and met on a number of occasions. The plan focusses on five main areas: Housing and the Built Environment, Economy, Transport and Infrastructure, Community, Leisure and Well-being and the Natural Environment; for which working groups were established. Public consultations were held on draft plans, and following comments and amendments, a Submission plan was put forward for independent examination. The Examiner recommended that the plan be put forward for referendum which has now been cancelled due to the Covid-19 emergency.

Once the Plan is adopted by SDC, anyone submitting planning applications must comply with the policies in order that future development respects the needs and character of the town. Alcester will also benefit from additional money that developers will have to provide for local infrastructure and facilities.



Meetings: Monthly

Responsibility: The Community Care committee is responsible for Older Peoples' Services, Young Peoples' Services, Community Safety and Community Transport. It also oversees projects initiated under ATC's Health and Wellbeing agenda.

Main activities of the year:

- Computer group for older residents increasing in numbers and renamed Well Connected
- Repair Café launched to enthusiastic support from residents, now meeting monthly
- Community outings arranged for older residents, including trips to Broadway and Gloucester Docks
- Cyber Crime event held at Malt Mill Lane Community Centre
- Christmas Day lunch held for a third year for isolated residents
- Public drop-in session held with the Environment Agency to review the town's flood defences
- Emergency Action in Event of Flooding session and refresher training held for all flood wardens
- Emergency and Community Flood Plans reviewed and updated
- First Aid training session held for councillors and flood wardens
- Window Wanderland event held, with a very positive response from residents
- Joined Shakespeare's England to increase publicity for Alcester tourism
- Community Allotment continuing and fully subscribed for the coming year
- Wassailing event held at the Community Orchard
- Carers Support Group launched, subsequently broadened to a more general support group and renamed the Cuppa Club
- Research project for Young People's Mental Health carried out in Alcester, online Mental Health Directory created and work started on making an awareness film to be shown in schools. Awareness session held for parents. Accredited Mental Health First Aid training arranged for and attended by young people from secondary schools in Alcester, Henley in Arden and Studley
- Bullying awareness sessions for parents and teachers held at the primary schools, utilising surplus funding from the Young People's Mental Health project
- Radio interview with ATC's Health and Wellbeing Coordinator on BBC Coventry and Warwickshire, talking about Alcester's Health and Wellbeing agenda. Series of shows with Stratford Welcombe Radio in progress
- Stratford RISE have continued to hold outreach sessions at the Depot, Eric Payne Community Centre to support parents and carers of young people in the town
- Successful bid for £5440 from Public Health to fund a series of Parkour sessions for the over 60s – project named 'Alcester – Get A Move On!'
- Award of Community Grants to 15 local organisations and societies
